mineral raw materials and steel products.

TTS (TRANSPORT TRADE SERVICES) S.A. ("TTS" or "the Company") informs that **two contracts for the provision of transport services were concluded with Liberty Galati S.A.**, with a cumulative value higher than the reporting threshold of 65,604,122 RON (10% of the net turnover recorded by TTS in 2022), calculated according to the provisions of art. 234 paragraph (1) lett. i) from ASF Regulation no. 5/2018 on issuers of financial instruments and market operations, with the following characteristics:

Parties: Liberty Galați S.A., CNFR NAVROM S.A. and TTS (TRANSPORT TRADE SERVICES) S.A.
