

Instructions for creating a shareholder account on eVote

1. Access the dedicated web page: <https://tts.evotero.ro/>
Recommended web browsers: Google Chrome, Mozilla Firefox, Microsoft Edge.
2. Press the "Register a new account" button

3. **Step 1** Select "Shareholder type" from the dropdown list:

 - ID number and series (without spaces ex. RX123456);
 - (optionally) phone number (without the number 0), please select the country code;

6. **Step 4** Upload the necessary identification documents (accepted formats: .pdf, .jpg, .png):
(for individual shareholders)

- Personal ID document

(for institutional shareholders)

- Personal ID document of the legal representative;
- Certificate issued by the Trade Register or a document issued by a competent authority of the state in which the shareholder is legally registered, attesting the existence of the legal person and the identity of the legal representative, issued after April 22, 2021.

The documents are loaded either by Drag and Drop from the place where the copy was saved on the computer or by clicking on the dotted box, which will open a navigation page on the computer, where the copy of the document is selected and the "Open" button is pressed".

8. The last button "Send me a receipt with my votes for my own records" - "Send me a note with my votes for my archive" is activated automatically.
